- Manage ATSC's participation in international organizations, including ITU, TSDSI, and CITEL, attending key meetings when required.

- Monitor and manage challenges related to standards fragmentation across different global regions.
- Support **Technology Groups, Specialist Groups, and Ad Hoc Groups** through agenda setting, attendance tracking, and parliamentary procedures.
- Attend these group meetings as a parliamentarian and ATSC staff representative.
- Oversee formatting, posting, and balloting of technical documents.

- Serve as an accomplished industry event speaker, representing ATSC at major global conferences.
- Assist the President and Communications team in strengthening relationships with key members and recruiting new members.
- Maintain liaison relationships with other Standards Development Organizations to align industry efforts and minimize standards fragmentation across different regional deployments.
